



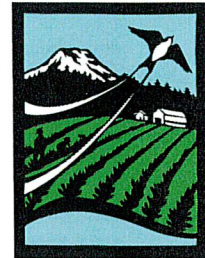

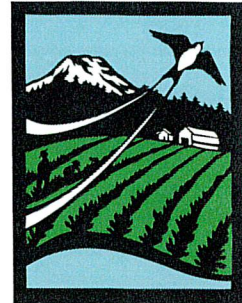


## Agritourism Advisory Committee
